
The boycotts were successful, but the English king (King George III) and Parliament believed the Americans should obey British laws and took power away from the colonies and sent more British soldiers.



An Act of Treason

 Many colonists who spoke out against the King of England, or even when people spoke of independence, feared treason.

 - Loyalist (or, Torie)



The Townsend Act + Boston Massacre

- The Townsend Act actually led some people to their deaths!
- The Townsend Act, of 1770, involved the British soldiers being allowed to search the property of colonists for no reason at all.
- If the British soldiers saw something they thought was "suspicious", they were allowed to take it away from the colonists.
- The colonists flipped!!!! The Boston Massacre is what happened. Do you know what this event is?



- On <u>March 5, 1770</u>, after the colonists boycotted buying any British items, the British soldiers and the colonists were very upset and angry with each other.
- A few colonists started calling some British soldiers names and throwing snowballs at them.
 – Can anyone guess what happened next?
- The British soldiers fired into the crowd of colonists and killed five (5), and injured six (6) others.
- Crispus Attucks was the first African American to die on colony soil.

The Tea Act + Boston Tea Party




AN AND DESCRIPTION OF ADDRESS OF

- The final insult to the colonists after the Boston Massacre was when the British placed taxes on the item they drank every single day – TEA!
 - The colonists wanted to stay as British as possible, and followed the daily tradition of drinking tea at 3:00 pm.
 - When England placed a tax on something they drank every day to keep the British tradition, this was enough!
 - Why do you think the colonists viewed these laws as attacks on their rights as British citizens?

The Boston Tea Party

- An angry group of colonists they called themselves the Sons of Liberty – decided they would rather destroy the tea than pay taxes on drinking it.
- They dressed up as Native Indians and snuck on the British ship holding large crates full of tea.
- They broke up the boxes and hurled everything into the water permanently destroying all the tea.
